Our pre-finished, ready to install PVC products are the perfect wood substitute with many advantages over wood; it's has a lifetime warranty not to rot, it has a durable surface, it will not chip, crack, peel or warp, and is insect resistant. Our product is better than wood and is offered in a range of wood stains and whites that are scientifically designed to yield high quality and durability.

PLASTIBEC WARRANTY STATEMENT

Plastibec Inc. "PLASTIBEC" warrants Plastibec rigid vinyl molding and wainscot extrusions the "PRODUCT" to be the finest quality available and to be superior for interior applications.

PLASTIBEC warrants that their PRODUCT will not blister, chip, corrode, peel, rot or suffer insect damage when used in accordance with the PLASTIBEC care & maintenance instructions. Each Purchaser of the PRODUCT is solely responsible for determining the effectiveness, suitability and safety of any particular use or application of the PRODUCT. Building code regulations vary from area to area. Each Purchaser should consult local building and safety codes for specific requirements.

PLASTIBEC's Limited Lifetime Warranty covers the original purchaser for a period of (residential) 20 years (less exclusions) and original purchaser (commercial) for a period of 10 years. This warranty is nontransferable and is subject to warranty exclusions. This warranty is limited to PRODUCT and the structures that the PRODUCT is affixed are not included in the warranty.

PLASTIBEC shall be given a reasonable opportunity to inspect and test the PRODUCT, its installation and the environment in which it was used prior to removal by the original purchaser. Failure to comply with these notice and inspection provisions shall void all warranties with regard to PRODUCT.

PLASTIBEC shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort strict liability or otherwise. In no event shall PLASTIBEC be liable for labor, installation, reinstallation, freight, taxes or any other charge related to defective PRODUCT. This Warranty does not cover and PLASTIBEC is not liable for damage or failure of the PRODUCT as a result of one or more of the following warranty exclusions:

WARRANTY EXCLUSIONS:

PLASTIBEC does not warrant against uniform fading or color change due to normal interior building conditions, as normal fading will cause any surface to gradually fade or darken. This warranty does not cover liability for incidental or consequential damages for any cause whatsoever.

PLASTIBEC warranty is void if any of the following occurs:

- Failure to abide by manufacturer's installation guidelines
- Movement, settling or collapse of support structure
- Naturally occurring instances such as earthquakes, tornadoes, hurricanes, flooding, lightning or any acts of God

- Improper handling, storage, neglect or misuse
- Improper application of PRODUCT or chemicals not recommended
- Failure to adhere to Manufacturer's recommended guidelines for application of painted surfaces shall void this Warranty.
- Ordinary and expected fading due to exposure to the elements; which for purposes of this Warranty is defined to be fading, chalking or darkening of the surface of the PRODUCT due to exposure to ultraviolet light.

This Warranty may not be altered or amended except in a written instrument signed by PLASTIBEC and the Plastibec Purchaser. No dealer or other person or entity is authorized by PLASTIBEC to make statements or representations regarding the performance of the PRODUCT except as contained in this Warranty, and PLASTIBEC shall not be bound by any such statements other than those contained herein.

PLASTIBEC makes no other representation or warranty of any kind, express or implied, in fact or in law, including without limitation, any implied warranty of merchantability, fitness for a particular purpose, or non-infringement.

INITIAL COLOR:

PLASTIBEC maintains strict production control standards and color tolerances, however, initial color variation will occasionally be found from batch to batch and rarely within the same batch.

PLASTIBEC does not warrant against variation in initial color. PLASTIBEC reserves the right to determine the range of acceptable initial color variation.

NORMAL FADING:

PLASTIBEC does not warrant against normal fading. PLASTIBEC reserves the right to determine the range of acceptable color change. PLASTIBEC conducts color studies on their materials.

Uneven color change will occur in areas that are not equally exposed to sunlight. Additionally, reflected light such as from windows, patio doors, siding, etc. will accelerate fading. Since initial color may accelerate color fading or change. This too is considered normal fading.

CARE & MAINTENANCE:

Foreign substances should be removed using warm water and a mild non-abrasive detergent or commercially available vinyl cleaner. For tough stains, more aggressive cleaning solutions will be required. Use at your own risk and be sure to check for harmful effects on a hidden surface.

Some chemicals or U.V. inhibitors such as insect repellants, pesticides or herbicides, etc. may cause discoloration if exposed to the PRODUCT for an extended period of time. (Use caution and clean PRODUCT immediately when it has been exposed to such chemicals.)

SURFACE DAMAGE:

Never use metal tools (wire brushes or sharp edge implements) to remove foreign substances from the PRODUCT.

WARRANTY NOTIFICATION:

The Original Purchaser must within 30 days of discovery of a claimed defect and prior to performing any repair notify PLASTIBEC in writing the nature of the defect, supplying pictures and proof of purchase.

PLASTIBEC reserves the right to investigate any claim hereunder. Upon verification of a claim, PLASTIBEC shall arrange for the delivery of replacement PRODUCT or, solely at its option, reserve the right to issue a cash refund equal to the original cost of the defective PRODUCT, not to exceed the purchase price paid by the Original Purchaser.

Replacement PRODUCT will be supplied as close to the original as possible, although this is not guaranteed to be an exact match. PLASTIBEC will not be liable for labor charges or other costs or expenses in connection with the repair, removal, or installation of the original or replacement PRODUCT.

To file a claim under this Warranty, the Original Purchaser must send proof of purchase, a picture of the defective PRODUCT and a written description to:
